**RE: Urgent Action Required on Synthetic DNA Contamination in Pfizer and Moderna COVID-19 Vaccines**

This letter requests that you urgently address the alarming findings detailed in the recent scientific [report](#) that Canadian virologist Dr. David Speicher prepared and then released through law firm PJ O'Brien & Associates. The report reveals unacceptable levels of synthetic DNA contamination in Pfizer and Moderna COVID-19 vaccines administered to millions of Australians.

According to Dr. Speicher's analysis, this contamination exceeds the acceptable regulatory thresholds up to 145-fold and contains sequences such as the SV40 promoter, which is known to promote genomic integration.

I draw your attention to the further compelling efforts of my parliamentary colleague, Russell Broadbent MP, who has presented to you in his [letter of 25 September 2024](#) substantial evidence that a formidable group of eminent scientists and medical professionals curated and endorsed. Their conclusions reinforce that if the contamination is pervasive across all vials of these vaccines, Australia may be facing a health crisis involving the wellbeing of the DNA of millions of Australians. The possibility of widespread genomic integration and the escalation of diseases such as cancer should not be dismissed. This situation requires your immediate intervention.

Joining with Mr. Broadbent, I strongly urge you to take decisive action. I call for the immediate suspension of the Pfizer and Moderna vaccines, pending a thorough investigation into the extent and impact of this contamination. As a first step, it is essential to task appropriate experts with conducting necessary studies to quantify the scope of this crisis.

This investigation must include immediate orders from the Therapeutic Goods Administration (TGA) and the Department of Health to secure sufficient quantities of vaccine vials that remain in the public domain. These vials are crucial for testing to confirm whether the contamination Dr. Speicher identified is present in all distributed lots. The scope of this inquiry must include:

1. Determining the number of Australians that this contamination potentially affects;
2. Contacting individuals who have received contaminated vaccinations to assess their current health status;
3. Securing sufficient evidence to potentially terminate indemnities granted to Pfizer and Moderna, thereby making these companies financially responsible for the consequences.

The possible victims of this contamination must be a priority for your government. Immediate action is required to stem any further loss or harm. The Science Summary in Mr. Broadbent's letter of 25 September 2024 clearly suggests that these grossly excessive levels of synthetic DNA, encapsulated in lipid nanoparticles, represent a health risk that cannot be ignored.

This is not a situation of minor regulatory non-compliance. The levels of contamination are scientifically and morally unacceptable, and immediate steps must be taken to protect the Australian public from further exposure.

I look forward to your swift response on this critical issue. To ensure the safety of all Australians please suspend these products and initiate a comprehensive investigation.
